### 1. Eligibility

The Trace Academia competition ("The Contest") is open to legal residents of South Africa who are at least eighteen (18) years old at the time of entry. Employees of TRACE Global and other companies/partners associated with the promotion of the Contest, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Contest is subject to federal, state, and local laws and regulations.

### 2. Sponsor

### 3. Agreement to Official Rules

Participation in the Contest constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. #### 4. Contest Period

The contest begins on 1 March 2021 at 8:00 a.m. CAT and ends on 21 March 2021 at 11:59 p.m. CAT (the Contest Period). Entries that are submitted before or after the Contest Period will be disqualified. #### 6. Prize Drawing

On or about 22 March 2021 TRACE will do a random draw to select the winner. TRACE will attempt to notify the potential winner via email or phone within 48 hours. If the potential winner cannot be contacted within two (2) days after the first attempt to contact him/her, TRACE may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries. In the event that a potential winner is disqualified for any reason, TRACE will award the applicable to an alternate winner from the remaining non-winning, eligible entries.

#### 7. Prize

One prize of a paid one month internship at Trace and a Trace Academia hamper will be awarded to one winner. The salary of the chosen intern will be R8000. Payment will be made by EFT and a valid bank account is necessary. The hamper will be given to the winner on arrival at the Trace Offices in Johannesburg. If the winner lives outside of Johannesburg, the winner will be flown to Johannesburg and accommodation will be provided for the duration of the two-week internship. A return flight will also be provided. All flights and accommodation will be limited to a cost of R10 000.

#### 8. General Conditions

In the event that the operation, security, or administration of the Contest is impaired in any way for any reason, including, but not limited to fraud, virus, bug, worm, unauthorized human intervention or other technical problem, or in the

event the Contest is unable to run as planned for any other reason, as determined by TRACE in its sole discretion, TRACE may, in its sole discretion, either (a) suspend the Contest to address the impairment and the resume the Contest in a manner that best conforms to the spirit of these Official Rules or (b) terminate the Contest and, in the event of termination, award the prize at random from among the eligible, non-suspect entries received up to the time of the impairment. TRACE reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to damage the website or undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, TRACE TV reserves the right to seek damages (including attorney's fees) and any other remedies from any such person to the fullest extent permitted by law.
